

## YMCA 'CREATE MAGICAL MOMENTS' PROMOTION - TERMS AND CONDITIONS (Terms)

### 1. OFFER AND ELIGIBILITY

- a. This 'Create Magical Moments' (**Promotion**) is offered by Victorian YMCA Community Programming Pty Ltd (ABN 75 092 818 445) of 502/990 Whitehorse Rd, Box Hill VIC 3128 (**YMCA**).
- b. By participating in the Promotion, you agree to be bound by these Terms.
- c. The Promotion is available at Ashburton Pool and Recreation Centre, Hawthorn Aquatic and Leisure Centre, Bass Coast Aquatic and Leisure Centre, Warragul Leisure Centre, South Gippsland SPLASH, Peter Krenz Leisure Centre, Benalla Aquatic Centre, Numurkah Aquatic and Fitness Centre, Gippsland Regional Aquatic Centre, Coburg Leisure Centre, Brunswick Baths, Fawkner Leisure Centre, Horsham Aquatic Centre (**Participating Centres**) between the dates and times of 06:00am 20 January to 11:59pm on 17 February 2025 (**Promotion Period**).
- d. The Promotion is not valid in conjunction with other offers, unless approved in writing by YMCA.

### 2. SIGN UP TERMS

- a. Participants are eligible for a single free swimming lesson when sign up occurs in the Promotional Period. A credit will be applied to your account prior to the first debit once you have signed up.
- b. The Promotion is only available with a minimum commitment term of 8 weeks.
- c. This Promotion is not applicable to existing swimming lesson members.
- d. The Promotion is only available at Participating Centres.
- e. The Promotion is available for Y swimming lessons not for school groups or holiday programs. It is available for infants, pre-school, primary school aged programs and teens etc (exclude schools and school holiday programs).

### 3. PRIZES

- a. Every new member who signs up during the promotional period is entitled to one opportunity to win a prize by spinning a wheel at the relevant Participating Centre.
- b. To claim the opportunity to spin the wheel, new members must visit the front desk of the Participating Centre during the promotional dates. It is the responsibility of the new member to initiate their spin within the specified period.
- c. The distribution of prizes will be coordinated by the Participating Centre. All prizes must be claimed and redeemed in person while stock lasts.

- d. These Terms are governed by the laws of Victoria, Australia.
- e. Members will be bound by their terms of membership with YMCA. To the extent of any inconsistency between the terms of membership and these Terms, these Terms will take priority.
